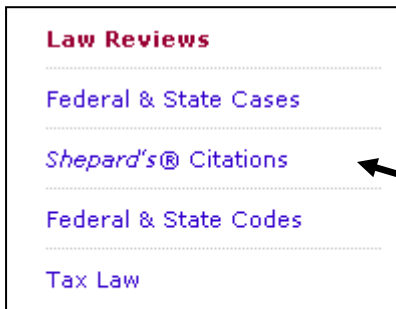




LexisNexis Legal

- Start at the library website, click on **Articles & Indexes**
- LexisNexis is available on several of the **Resources by Subject** pages, including: **General and Interdisciplinary** and **Business**
- Click the **Legal** tab



Law Reviews

LexisNexis Legal starts off searching the Law Reviews.

For other legal searches (federal and state cases, tax law, etc.) select the links on the left.

Click on **Natural Language**. Terms and Connectors is an advanced search that can be somewhat confusing.

Enter search terms, and any required terms (optional).
Search terms can include keywords, case names or citations.

Specify a date range (toward the bottom)

From the results page, View **Expanded List** shows the search terms in context.

Case Law

On the Legal search page, click **Federal & State Cases** from the menu on the left.

Click on **Natural Language**. Terms and Connectors is an advanced search that can be somewhat confusing.

Search

Enter a question, a sentence, or a few descriptive terms. Use quotation marks for an exact phrase. Do not use wildcard characters such as ! or *.

Required Terms (Optional) Specify terms that must be found in retrieved documents:

Specify date

To search by topic, enter search terms, and any required terms (optional)

You have the option to:

- ✓ Select a source (Federal Courts, U.S. Supreme Court, Tax Cases, State Courts, etc.)
- ✓ Specify a Date Range

To search for a specific case enter the case name, or citation number.

Searching by Judge and Counsel's name is also available.
